# DECLARATION OF NOMINATED CLUB

In accordance with the Constitution, By-Laws and Conditions of Play of Cunningham District Bowls Association and Bowls Queensland a player who is a member of more than one club must declare their nominated club for **championship events that advance to a higher level.** Championship events are Singles, Pairs, Fours and District Sides.

Please note: in order to play Pennant Competition within Cunningham District Bowls Association or any other CDBA controlled competition /event, including selection in CDBA Sides, election to CDBA Management Committee or CDBA Council a player must be a financial club member of and have nominated for a club affiliated within the Cunningham District Bowls Association.

The Club Secretary must keep all player declaration forms in a safe place and produce these upon request by any authorized Cunningham District Bowls Association Match Official or Authorised District Representative.

#### NOTES FOR THE APPLICANT

## **Declared players**

A player must declare only one (1) of those Clubs in one (1) State or Territory Authority(STA eg. Bowls Queensland) as their Nominated Club for the purpose of playing in State Championships and other championship events conducted by BQ (or other STA) or BA during a Bowling Season (all to be defined by the relevant STA).

# **Application for Membership**

- This declaration form should be completed at the time of application for Club Membership.
- It is the applicant's responsibility to list of ALL bowls clubs that the applicant is currently a full financial member of (all Districts and all States) and to obtain a clearance from each of these Clubs (CDBA BY-LAW 15 refers)
- In applying for membership of a CDBA Affiliated Club, players/members agree to abide by CDBA rules and policies and those of Bowls Queensland (e.g. Member Protection Policy; Code of Conduct Policy; Conflict of Interest Policy etc)

#### CDBA BY-LAW 15. CLUB MEMBERS

- (a) Any member who holds membership with two (2) or more Clubs shall pay all affiliation, Capitation Fees and any other levies for each Club of which they are a member.
- (b) No person shall be admitted as a member of any Affiliated Club who is, or has been a member of any other Affiliated Club or any other Bowls Association unless they satisfy the Committee of the first mentioned Club that they do not owe any entrance fee, subscription or other monies to any other Club.
- (c) Upon resigning, or joining another affiliated club, the Secretary of that members affiliated club shall issue the official Bowls Queensland inter-club clearance.
- (d) The Secretary of the club from where the player is leaving or joining another club shall certify on the official Bowls Queensland inter-club clearance if the player is under suspension or expulsion.
- (e) The By-Laws of all CDBA affiliated Clubs shall contain a clause requiring that all resignations must be received and acknowledged in writing by the Secretary of the Club. No person shall be deemed to have resigned from a Club unless their resignation is in writing and delivered to the Club and until any outstanding discipline or other proceedings being undertaken against the member are concluded.

### NOTES FOR CLUB SECRETARY

Club Secretary must notify <u>all</u> other Clubs listed on the form and the Secretary of the CDBA that this member is now a member of your Club and advise whether they are declared/non-declared member of your club. This advice may take the form of an email.

This information must also be included on the Form 2 that is sent to BQ and CDBA each month.

It is recommended that only declared players be eligible to compete in Club Championships. Declaration of Nominated Club- CDBA 16 November 2017
